OCL Study Reports

Health Inequalities in Syracuse and Onondaga County-2007 Study

OCL Board members Betty DeFazio and Mavra Urrutia are the co-chairs of the current study of the problems associated with inequalities in health outcomes, health status, and access to healthcare in Onondaga County. The study committee, established as its mission statement: To inform and mobilize the community about inequalities in health outcomes, health status, and access to healthcare in Onondaga County. In addition to describing and promoting understanding of the problems, the committee hopes to develop specific recommendations to address the causes of inequalities.

The work of the committee began in the spring, with review and discussion of recent studies and reports on the issue of disparities nationally. Throughout the spring and summer, the committee held discussions and public sessions with local experts on the areas established for focus: maternal and child health; chronic disease; long-term care; HIV/AIDS; nutrition; and lack of health care coverage. The study report is due to be completed and released in early 2008.

Downtown Study and Follow-up-OCL's 2006 report, "Leveraging Better Outcomes for Downtown," released in April 2007, recommends a number of public

policy initiatives to enhance the prospects for new investment in the downtown core over the next decade. Recommendations include implementation and enforcement of a sound and thoughtful downtown master plan, establishment of a municipal parking entity for coordinated management of parking resources, enactment of an effective NYS historic tax credit to help spur the rehabilitation of downtown's historic building stock, and enhanced public improvements and marketing efforts.

With the support of the county executive, and the appointment by the mayor of study co-chair Doug Sutherland to head an implementation task force addressing city policies, many of the report recommendations are already under consideration by city, county and business leaders. Study co-chairs, Joe Ash and Sutherland, are working with the Economic Development Leadership Team (including the county executive and the mayor) on an implementation plan to tackle several major issue areas beginning with parking, the Convention Center project and its connection to downtown, and leveraging growth of the medical and educational institutions on University Hill to benefit downtown.

2007 Downtown Living Tour-Downtown residential is leading

the current reinvention of downtown, so to showcase the diversity of existing downtown housing,

OCL presented a Downtown Living Tour on Saturday, May 19. Nearly 2,000 people attended the first-ever Downtown Living Tour, organized following the issuance of the 2006 study report. Included were a dozen apartments, lofts and condominiums, including historic renovations and new construction, as well as projects in design or underway. The downtown 'parade of homes' replaced the usual OCL Community Leadership Conference and highlighted the many creative housing options already existing downtown. The website for the tour is www.downtownlivingtour. syr.edu. The Downtown Committee of Syracuse, one of OCL's partners in planning the event, will take the lead in organizing another downtown living tour in 2008.

Government Consolidation Study Follow-up-The "Strategic Government Consolidation" report forms the basis of Syracuse 20/20's Government Modernization Project. The grassroots effort, in which many OCL members remain involved, attempts to grow support among the general public for changes in government, in order to compel politicians to make changes necessary to sustain Upstate New York. Political Participation Study Follow-up-Acting on one of the recommendations in the Onondaga Citizens League's 2004 study, "Disappearing Democracy? A Report on Political Participation in Onondaga County," the Syracuse League of Women Voters has organized a Citizen Fact-Checkers **Project** to analyze the accuracy of campaign advertisements and help voters make informed decisions. OCL Study Committee members served on the planning committee.
