**New study committee member:** David Coburn, director, Onondaga County Office of the Environment and chair, county Environmental Sustainability Committee.

#### DISCUSSION

The upcoming <u>September 29 study session</u> was discussed. Emanuel said that he would include more local ecosystem perspective as well as the Vitoria case study. Richard Smardon will also participate and talk about Tompkins County sustainability plan and other northeast examples.

Dave Coburn agreed to take on the <u>Waste Management topic</u>. He will develop a proposal and contact Tom Rhoads at OCCRA about speaking. Rick suggested that SU's "recycling czarina" could represent the perspective of a major waste generator in the discussion.

Sandra suggested that OCL could provide registration for the Nov. 5 event for committee members who would like to attend and report back to the committee.

Jonnell Allen, SU community geographer was not able to attend due to a family emergency, but Sandra will discuss possibility for <u>Sustainability Map</u> with her, for report at the next committee meeting. Evan said EFC is hoping to create a website that tracks sustainability projects in CNY, with EPA funding, but no timeline yet. **Definition of Green**: environmental impact subset of Sustainability Traits, focusing on "reduce, recycle, reuse" principles

- 1. what are we doing Green? Is it enough? (An assessment; comparison to benchmarks)
- 2. How can we be more Green in CNY? (look at other places, model practices)
- 3. How do we make sure that the decisions we make have a beneficial effect on the environment?

**Timetable:** Study Report to be completed by May 1, 2010.

**Audiences:** individuals/families; business and organizations; municipalities. For the purposes of the study, the local community is defined as Onondaga County, although we may touch on other places in the metropolitan area.

**Potential Study Session Topic Areas** - **Subgroups will focus on:** Ecosystems (Sept. 15 – Notes on the website); Sustainability; Land Use Planning; Transportation; Energy Supply; Green Bldgs & Housing; Waste Management; Water; Green Infrastructure; Green Jobs, etc.; Case Studies of holistic approaches to sustainability; Natural Resources (TBD). Public Perceptions Subgroup works with all topic areas.
